

PRIVACY STATEMENT

1. GENERAL

We respect your privacy and handle your personal data in accordance with the UK General Data Protection Regulation (UK GDPR) and the Data Protection Act 2018. 2. PERSONAL DATA

If we share your personal data with a recipient in a country outside of the United Kingdom, we will ensure that this transfer takes place in accordance with applicable laws and regulations.

6. PROTECTION OF PERSONAL DATA

Tummers Simon Dryers Technology will ensure suitable technical and organisational measures to protect your personal data against illegitimate and unauthorised processing and loss, destruction, damage, modification, or disclosure. If Tummers Simon Dryers Technology makes use of services of third parties, Tummers Simon Dryers Technology will capture agreements on adequate security measures in a processor agreement in the context of the protection of personal data.

7. RETENTION PERIOD

8. YOUR PRIVACY RIGHTS

We will assess whether we can honour your request based on legal provisions. As a rule, we will inform you within one month of the receipt of the request. You also have the right to lodge a complaint with the Information Commissioner's Office (ICO).
